Overall revenue grew by 12.89%, for the 6 months ended 30 September 2008 compared to the corresponding period in 2007 on the back of the growth in China's import market which has remained relatively strong despite the current financial crisis. .

The express land transport division, engaged mainly in the provision of logistics services for the import of factory inputs and finished goods into China, continued to be the main income contributor for the Group. At the same time, the newly establish airfreight division that provides services catering to export of goods from China to the rest of the world, saw a significant growth.

Gross profit margin decreased by 4.73% from 42.80% in the previous half year to 38.07% for the current half year. The decrease was mainly due to a rise in the cost of customs clearances during the 2008 Beijing Olympics period. In the 3 months before the Olympics up to October 2008, additional security checks were imposed on goods carried into China. Such costs were passed on by the customs authorities in the form of higher customs handling charges. In addition, customs taxes were temporarily raised to discourage the inward movement of goods during the Olympics period. However, such measures were lifted in mid-October 2008 after the completion of the Paralympic Games. Customs taxes and handling charges have since returned to normal.

c) Other Income

Compared to the same period in 2007, other income increased from HK\$0.25 million to HK\$1.04 million for the six months ended 30 September 2008. This was mainly due to gains on disposal of motor vehicles of HK\$823,000 compared with only HK\$30,000.

d) Selling and Distribution Expenses

Selling and distribution expenses rose 5.47% to HK\$2.62 million in line with the increase in revenue.

e) Administrative Expenses

Group administrative expenses increased by 20.17% to HK\$16.07 million largely due to Singapore Dollar denominated corporate expenses incurred by Sky One Holdings Limited ("SOHL"). There were no such expenses before as SOHL was not part of the Group then. Furthermore, in anticipation of more business activities, staff strength was increased during this period.

f) Profitability

Profit before tax decreased by 22.17% to HK\$6.96 million in the first half of this financial year compared to that of the previous year mainly due to the increase in customs clearances costs during the period around the Beijing Olympics as discussed in b) above. The increase in corporate expenses has also affected profits as discussed in e) above. Accordingly, profit after tax decreased by 20.92% to HK\$5.60 million. The effective tax rate of 19.6% is higher than the Hong Kong corporate tax rate of 16.5% due to expenses not deductible for tax purposes.

g) Cash and Borrowings

The group generated a net cash inflow from operations of HK\$4.28 million during the 6 months ended 30 September 2008. This was offset by payment in the current period of tax assessed for prior years totaling HK\$6.59 million. As at 30 September 2008, the Group had cash and cash equivalents of HK\$3.32 million.

During the first half of this financial year, the Group borrowed HK\$3 million of which HK\$2.76 million is outstanding as at 30 September 2008 (31 Mar 08: HK\$ Nil). The outstanding balance for the leasing of plant and machinery as at 30 September 2008 is HK\$0.51 million (31 Mar 08: HK\$0.73).

10. A commentary at the date of the announcement of the competitive conditions of the industry in which the group operates and any known factors or events that may affect the group in the next reporting period and the next 12 months.

During the six months ended 30 September 2008, costs of sales were affected by increased customs clearance costs. This occurred on a temporary basis, from the months leading up to the 2008 Beijing Olympics to mid-October 2008. The rise in costs was attributable to the increase in inspections, higher customs charges and taxes to discourage imports into China so as to ensure the smooth running of the Olympics. However, such costs have been lifted since the middle of October 2008 and are not expected to recur.

Despite the current financial crisis and expected slowdown of the world economy, the Group is still optimistic of its future prospects. The Chinese economy is still expected to grow, albeit at a slower pace than previously anticipated. The Group services a large and broad group of customers across different industry sectors and thus, is able to benefit from diversification of its sources of income.

As announced on 1 November 2008, the Group has entered into a Sales and Purchase Agreement for the proposed acquisition of JET INTERNATIONAL. The acquisition, if successful, will improve the Group's business in the following areas:

- i) Expand Sky One's logistics services business into the PRC Market
- ii) Widen Sky One's business network in China
- iii) Reduce reliance on third party service providers
- iv) Expand and diversify customer base further
- v) Acquire a PRC Class 1 Logistics Licence
- vi) Obtain immediate access to the Taiwan market
- vii) Obtain support for the business development of the Group.
